



## GRASS CUTTING FOR CUYAHOGA HEIGHTS SENIOR CITIZENS

“*Spring Time*” is right around the corner and once again the Cuyahoga Heights Service Department will be cutting grass free of charge for our Senior Citizens and disabled persons who qualify. According to the Ordinance,

- (1) Only those persons who are **sixty (60) years of age and older** and reside alone or with a spouse of like age or older, may have their grass mowed.
- (2) Only those persons who are **disabled**, and *who do not have an able-bodied person (under sixty (60) years of age) living with him or her*, may have their grass mowed.
- (3) The resident senior, **sixty (60) years of age and older**, must own the home or be a renter who has the responsibility of cutting the grass.
- (4) The registrant must execute a consent and release, in a form approved by the Solicitor, granting permission to the Village to provide the grass cutting service and releasing the Village, its servants, agents and employees from any liability arising out of the cutting of grass on the registrant’s property.

Please note that if time permits, the Service Department will trim along the base of the resident senior’s property. Also, please be advised that we are not responsible for grass length. The grass cutters are set at a standard height and will not be changed.

If you currently do not have a release on file, please call the Village Hall at (216) 641-7020 and we will mail you a release to sign.
