#### **Building Department:**

#### Winter Safety Tips

- Never use fuel-burning appliances (such as propane, kerosene, and charcoal) which give off toxic fumes unless direct vented to the outside.
- Check all electric heaters for proper wiring.
- Never use flammable liquids to start a fire in fireplaces.
- Never close fireplace dampers when ashes are hot.
- Make sure that fireplaces are screened or protected to contain embers.
- Check fireplace and chimneys excess (soot and/or creosote) at least once a year prior to the first use of the season.
- Furnace should be checked before each winter/summer use for filters filters should be changed every month or as recommended by the filter manufacturer.





## From the Clerk:

As we look towards the end of another year, our finances are very solid. All of our bills are paid and we will end the year with money in the bank. I project that we will surpass our beginning of the year estimates and end the year with a larger surplus in the bank than we originally estimated at the beginning of the year.

As you can see from the RITA chart, the revenue that we receive from taxes will be approximately 4% higher than last year. The other major variable in our revenue stream is the revenue we receive from the speed cameras. This money does not go into our General Fund, but into the Capital Projects Fund. It can only be used for large projects and not for employee's salaries.

Our budgets are constantly monitored by the Mayor and me. At the end of each month, I email the Expense Report to all of the department heads and the Mayor. This helps them stay within their budgets and control costs. There are no surprises, and when a department goes over budget, they are asked to explain the discrepancy and have a plan to correct it. The Mayor and I are both constantly assessing our financial situation. At this time, we are sound financially, and looking ahead to budgeting for next year.

The Mayor, Council, and I have all worked very hard to make the right choices regarding the budget and spending while maintaining a surplus in the bank for emergencies. As the Clerk, I am very comfortable with our cash position and will continue to work with the Mayor and Council to keep our Village solvent.

Did you know?

**State law prohibits texting while driving.** Ohio Revised Code: 4511.204 Village of Cuyahoga Heights Codified Ordinance: 432.45

If you're under age 18:

## It is illegal to use any electronic wireless communications device while driving in Ohio.

This means: No texting No e-mailing No talking on your cell phone, Bluetooth, Bluetooth speakers, On-Star or any similar device No computers, laptops or tablets No playing video games No using your GPS (unless it's a voice-operated or hands-free device) Even when you are sitting at a light or stuck in traffic

#### It's a Primary Offense: Law enforcement can stop you for any of the above reasons.

*First violation*: \$150 fine, driver license suspended for 60 days *Second and/or subsequent violations*: \$300 fine, driver license suspended for one year *Exceptions*: Pre-programmed GPS, vehicles in a stationary position and outside a lane of travel, emergency calls to law enforcement, hospital, fire department, etc.

#### Adult drivers (18 years or older):

# It is Illegal to use a handheld electronic wireless communications device to write, send or read a text while driving in Ohio.

Minor misdemeanor, could face a fine of up to \$150



#### The 5 W's to remember when calling 911

Where: Where is the emergency occurring; at your location or another location? What: What is going on? Why is this happening?

When: When did the emergency occur?

Who: Who needs help? Who is calling?

Weapons: Any weapons involved in your emergency?

Residents please update the dispatch center with any new telephone numbers you would like added or numbers that may need to be removed from our Swiftreach emergency contact system. This would include if you no longer have a house phone (land line) and only use a cell phone. The Swiftreach system is for emergency notifications. The phone numbers are kept strictly confidential and not given out to the public. You may also make these changes on the Village webpage.



## **Service Department:**

#### Leaf Pick Up

Fall is here and we would like to remind our residents to rake their leaves to the tree lawn; our Service Department will then dispose of them for you.

#### Yard Waste



Yard waste (i.e., grass clippings, tree branches, leaves, etc.) must be put in bags or separate trash cans, <u>not in the 95</u> gallon Village issued grey trash cans or blue recycling cans.

#### Just a Friendly Reminder:

All trash must be placed in garbage bags prior to disposing of in the Village issued trash cans. Your cooperation is appreciated.

#### **Snow Removal Program**



Residential Snow Removal Program for our 2014/2015 season.

- All Village roadways will be plowed first and maintained prior to any driveways being plowed.
- Once the Service Director feels that the roadways and municipal buildings have been maintained, the driveways of our senior citizens will be plowed (using the same criteria that applies to our grass cutting service).
- Afterwards, taking into consideration manpower, time and safety issues the Village will help residents with their driveways in the event of a storm that produces more than 2-4 inches of snow at the resident's request.

All residents must have driveway markers in place in order to allow the Service Department to plow their driveway. The Village will provide markers and place them for all seniors who qualify for the "grass cutting program." Residents with shorter driveways need 4 markers in place, and long driveways must have 6 markers. They need to be placed at the beginning, middle (if long drive), and at the end of your drive. If you wish to purchase markers from the Village for \$1 each, please stop at the Service Department. Should you have any questions please contact Service Director, Scott Waldemarson at 216-641-3505.

Please note that residents are responsible for cleaning their driveway aprons, as it is difficult to plow them over again after the streets are plowed. Each homeowner and/or resident must have a waiver of liability on file at our Service Department. If you already have filled out a waiver of liability and there have been no changes to it, there will be no need to fill out a new one.

#### **Table and Chair Rental**

Tables and chairs can be rented from the Service Department (limit of three (3) tables and 30 chairs). You must pick them up and bring them back to the garage. You will need to stop in at the Service Department and sign the loan form.
