## MAYOR BACCI:

The Village Hall and Service Department will be closed this Monday in observance of Presidents Day. Rubbish collection will resume on Tuesday.

## MS. BIRO:

She would like to make the statement that she was highly disappointed because they received the budget 24 hours before the meeting, and it did not give us enough time to look at it, discuss it, or ask any questions. I thought we were going to have an hour meeting before our Work Session concerning the budget, and she did not like breaking practice. She wanted to make her intentions very clear for the record.

## MR. BLOAM:

Mr. Bloam had a public Works Meeting before the Council Meeting. We will have a report for the Workshop on projects that were passed over in 2014, and recommendations from the committee for 2015.

# MR. CONTIPELLI:

We had an Economic Development Committee Meeting, and we are looking forward to discussing some things with Council in the future. The committee also agreed with Mr. McAndrew of Silverload to go ahead and initiate trying to get the SAFER Grant in 2015. Silverload will spend approximately 10 hours assembling the information to submit to the State. They feel our chances are very slim, but the committee agreed that if there was even a slim chance we should go for it.

# MS. DUSZYNSKI:

The majority of the Finance Committee approved the demolition of the Willow House to Mitchell Equipment for \$18,000.00. Service Department Director Waldemarson felt this was a good time to do this. It would not interfere with traffic or any events at Klima Gardens. We also approved a PO to Ecco Excavating in the amount of \$23,500.00 for work done at the Bacci Park concession. The Mayor stated that this work actually cost us \$8,300.00 because we received a check for \$15,200.00 from the previous company that originally did the work.

Ms. Duszynski thanked the Mayor for getting out the budget. She was a little bit surprised because past practice it came to the Finance Committee first, but the Clerk decided to send it out to all of Council. She explained that she was told by the Clerk that the reason he did this was because the Appropriation Ordinance was coming up for a vote the next day, and he thought that all of Council should see the budget before voting on the appropriations. She was wondering if the Mayor was changing past practice where the Finance Committee would get it before it went out to the whole Council. Clerk Unger stated that the Mayor was in the hospital, and he knew that Council would get the Appropriation legislation within a day, so he made the call to pass it out to all of Council. I sent out an email explaining that I made the call, and that I understand that in the past we did it differently, but I believed it was the right thing to do, and stand by my decision.

Ms. Duszynski asked if this is the way we are going to do it all the time. Clerk Unger stated that the Mayor will make the call on how he wants to do it in the future.

Ms. Henley asked if we got any other quotes to tear down the Willow House. The Mayor explained that they did not get any other quotes. They have used Mitchell before, and they are located in our community, so we try to get them as well as all the other business work that needs to get done. She asked when it is scheduled to come down. The Mayor said that there are some EPA issues that need to be addressed before we get a firm date.

## MS. HARRIS:

Ms. Harris asked Lee Ann if she would get another notice in the newsletter about the Water Aerobics classes at the High School swimming pool.

## MS. HENLEY:

She wanted to commend Police Chief Sturgill for sending the four policemen up to meet the seniors during their meeting. She hopes it continues because the seniors loved it. They were especially interested in our new police cadet Mr. Kevin Stack because his sister Kelly was on the Olympic Hockey Team that received a Silver medal at the last Olympics.

## FIRE CHIEF CASH:

Chief Cash welcomed the Mayor back after surgery.

## HEAD DISPATCHER CASH:

## SERVICE DIRECTOR SCOTT WALDEMARSON:

# CHIEF STURGILL:

A group of Veterans had a bus accident on their way downtown, no one was hurt, but the bus was disabled. They all came up to the Police Department, and Head Dispatcher Cash and his assistant Debbie Reiger made them all comfortable while the Chief called Scotty to see if there was something we could do for them to get them to the VA Hospital. Scotty coordinated it to help get them to their destination. It was a job well done by all involved, and shows we are truly a community of services.

He has been working on the street light situation today. It turns out that the person we would call to report a light out is no longer working for the Illuminating Company so now he has a contact to go to in the future. Also, our zip code is 44125 which is a Cleveland zip code. Recently Cleveland bought all of their street lights, and now they do them themselves, so they were not coming out to do the work because they thought we were in Cleveland. We think we have now rectified the situation, and hopefully next week we will get the lights fixed.

The Mayor wanted to let Council know that if they are getting any complaints from residents concerning the noise from a discharger on Warner Road, that Mr. Casini has been looking into it because it becoming more prominent. Mr. Contipelli said he dealt with this company before and all they had to do is rebuild the soundproofing around the machine, so it is probably time for them to do it again.
