## **MAYOR BACCI:**

They purchased the building next to them (formerly Stanek Windows), and a portion of the building will be used as a training center. Tomorrow afternoon, we will be stopping by Timan Window Treatments for their grand opening at their new location - 4533 Willow Parkway. There's a lot going on as it relates to construction and our businesses in town - Charter Steel, Southerly, MilliporeSigma, Northern Stamping – things are well.

Earlier this afternoon, myself, along with the Fire and Police Chiefs attended "*Prom Promise*" at Klima Gardens. This is a wonderful program for the high school kids to see and be a part of before they attend the Prom. Cuyahoga Heights Prom is this Friday.

Next Monday, May 15 is Peace Officers Memorial Day. Also, that entire week is Police Week -- special recognition is paid to those law enforcement officers who lost their lives in the line of duty. On Friday morning, May 19 the annual parade and service will take place in downtown Cleveland.

# MS. BIRO

The Economic Development Committee had a meeting this evening. We discussed the following grants.

Northern Stamping has accepted a \$50,000.00 beautification grant from the Village, and is working with the Building Department to identify appropriate exterior renovations.

Cuyahoga Heights, Valley View, Brooklyn Heights, and Newburgh Heights has been awarded a \$230,648.00 grant for the purchase of sixty seven portable radios. Of this award, \$51,637.00 will be used by the Cuyahoga Heights Police Department to purchase of fifteen radios. The grant requires a 10% cash match, so the Village will be paying \$5,737.00 for the radios.

The Cuyahoga Heights CIC has issued a grant to Dougherty Capital Partners in the amount of \$35,000.00 for beautification of the Heat Seal building, in connection with the securing of Hajoca Plumbing Supply as a tenant.

The Village previously applied and was not awarded funding for a FEMA Fire Protection Safety Grant, and is currently working with Silverlode to reapply for approximately \$25,000.00 to be used for Knox Boxes and smoke alarms.

The Village has been awarded \$50,000.00 from the Cuyahoga County Community Development Supplement Grant to acquire and demolish residential properties. The Village has identified four properties for acquisition and demolishion.

In 2011, the Village received a Gateway Grant from ODOT. They have since cancelled the funding for this program, but ODOT intends to reopen this program and we will be submitting another application in the near future.

## MR. BLOAM:

There will be a Public Works Meeting Wednesday, June 14th, at 5:30 pm.

## MS. DUSZYNSKI:

Todd Bloam, Cheryl Harris, and myself had a Finance Committee Meeting this evening with Clerk Unger and Assistant Clerk Meriwether in attendance. They discussed the General Fund, and asked Mr. Unger what he feels is a healthy amount of money to have in the General Fund. Mr. Unger said that in his opinion, we should have at least one million dollars in our General Fund for emergencies after paying all of our salaries and bills.

The Finance Committee approved PO's to C&K Industrial for \$25,000.00 for catch basin cleaning during the year, \$6,200.00 for Mitigation Analysis at Nicky Beaulevard, \$160.00 for dugouts and backstops at Bacci Park, and \$5,100.00 to Independence Cement for sink hole repair on E. 49<sup>th</sup> Street.

The Arbor Day was well received by everyone, and we ended up planting 14 new trees at Bacci Park.

### **MS. HARRIS:**

Ms. Harris stated that they caught one of the people involved in the theft of millions of dollars from Cuyahoga Heights High School in a foreign country, and he will be deported to the United States to answer for his crime.

Prom promise was wonderful, and said that it really makes an impact on the students, as well as all the adults in attendance. She saw many people in tears during the performance.

### **MS. HENLEY:**

Ms. Henley stated that we had a great turnout for Arbor Day. Since we started it eight years ago, it has changed into a wonderful, moving event for our Village residents. Many families come together to plant trees in their loved ones name, and it is very emotional. We should all be very proud of where we have come with this event, and it will be a living memory of all the residents we have lost over the years.

### **MR. SCHOEFFLER:**

Mr. Schoeffler planted a tree at Bacci Park for his daughter Claire on Arbor Day, and said it is a wonderful tradition for our Village residents.

## SERVICE DIRECTOR DAVE SAMMONS:

We will be sweeping the streets on May 20 and 21<sup>st</sup> for Memorial Day.

# HEAD DISPATCHER BARB CASH:

Chief Suhy stated that the Prom Promise went increadibly well, and because of the location being close to the school, it will be here every year.

# **CHIEF STURGILL:**

Chief Sturgill wants everyone to know that summer is right around the corner, and we need to watch for them on the streets while we are driving. Slow down, and be more carefull.

There has been a recent increase in drug and armed robbery arrests in the Warner Road area, and everyone should be watching for suspicious people in our Village. We chased robbery suspects through the landfill at North American near Grant Avenue, and arrested four suspects.

We need to be more vigilant of people walking, biking, and driving through our Village, especially in the summer when it gets warmer and more people will be out.
