MAYOR BACCI:

MS. BIRO

Ms. Biro wants to have a Codified Ordinance Meeting at 5:00 pm on April 25th. She asked if all members of the Committee were available and they said they were, so the meeting is scheduled for April 25th at 5:00 pm in Council chambers.

The Finance Committee met tonight, and approved a Mission Statement, and spelled out the duties and responsibilities of the Committee.

CFO Meriwether showed them the new VIP Finance Program that will be instituted in April. The new software is very impressive and will strengthen internal controls and forecasting.

If you look at the March financial statements, you will see that we are spending more than we are taking in for revenue. Although we should see an increase in revenue in the second quarter, we need to be careful that we don't purchase everything at one time. She asked the Chiefs to work with CFO Meriwether to schedule purchases so that we can more easily budget for the year.

She wanted everyone to know that the Village checkbook is not just one persons, but everyone's responsibility. As we move through the year, it is all of our responsibility to manage the money, and stick to the budget. We are all in this together.

MR. BLOAM:

Nothing at this time.

MR. CENTA:

Nothing at this time.

MR. CONTIPELLI:

He had an Economic Development Meeting with Silverlode, and we are doing everything we can to secure grants for all the projects in the Village.

Our SAFER Grant for the Fire Department is running out, and he was wondering if we were going to ask for another one. Mayor Bacci said he is in discussion with Chief Suhy, and we will see if this is something we need at this time. The new SAFER Grants come with a new rules stipulations that the Village pay 25% of the total for the first year, and 65% of the total for each year thereafter, which is a lot of money. We will sit down with the Chief and discuss our options before making a decision.

Mr. Contipelli brought up the fact that 25% of all accidents are caused by the driver texting on their cell phone, causing 500,000 injuries a year. He would like Council to consider legislation making this a fineable offense. Mayor Bacci explained that we recently passed legislation for an offense called "full time attention" that he believes covers this. Assistant Law Director Chojnacki agreed, and said that the legislation that we currently have gives us a broader interpretation, and will allow a Policeman to stop a driver for anything that takes away their full time attention, whether it is texting or talking.

MS. HARRIS:

Thanked Norm Casini and Kenny LaBella in the Building Department for giving her a spreadsheet on the rentals in the Village.

She still needs help for the Centennial Celebration, and is asking anyone if they could donate some time, please contact her. Mr. Contipelli said he would be interested in starting a Bacce Ball tournament, and Mr. Bloam said he might be interested in a Corn Hole tournament. Ms. Harris asked them to see if there was enough interest in these tournaments, and get back to her.

MR. SCHOEFFLER:

SERVICE DIRECTOR DAVE SAMMONS:

Went over some of the items that they sold at auction from the Service Department. Some of the items listed sold for more than they expected.

HEAD DISPATCHER BARB CASH:

Thanked Council for passing the Resolutions pertaining to Dispatch, and reminded everyone that it is National Telecommunications Week, please thank your Dispatchers for their hard work and dedication to the community. She said the group of Dispatchers that work for our Village are consummate professionals, and she is proud to work with all of them.

FIRE CHIEF SUHY:

Chief Suhy informed Council that they applied for a grant for SCBA equipment with the County, but did not get the grant. He said he will try again next year.

POLICE CHIEF STRURGILL:

Thanked everyone involved for their help in getting the police radio changed to 800 mghz. It took a long time and lots of work, and also received two grants to help us pay for this, but it was well worth the wait. We went live this Monday, and the radio sound is incredible. We should all be very proud of everyone's efforts on this project.
