Mr. Contipelli asked if this cost included some of the other projects that we talked about, including Canal Road. Ms. Meriwether said we are going to have a Public Works meeting to go over the other projects.

Ms. Henley asked why Canal Road is so much lower in price than Nicky Boulevard. Ms. Meriwether said it is because of the sewer lines in the Nicky Boulevard project that increases the cost.

Mr. Contipelli asked what we will do with any money that is not spent for the project. Ms. Meriwether said that is the estimate that was given to us by the Engineer, and we expect to use it all.

Mr. Centa asked if this was like a home equity loan where you just pay the interest on the money you take out. Ms. Meriwether said no, as soon as you pass the legislation, we get the money, and we will pay the interest on the full amount. He asked if the money collects interest on the money before we spend it. Ms. Meriwether said we don't collect any interest on the money, that is not allowed by law.

Mayor Bacci said that after the water main break on E.71st Street, he has had some major concerns about the stability of that portion of the road, and they are starting to develop. So in a meeting with Mr. Sciano this afternoon, we want to do some geotech slope stability analysis.

There was a lengthy conversation concerning the slope failure in that area, also on private property in that area, and what we can do to fix it. Mayor Bacci said we are looking into all options to fix this problem, but we have to be very careful in what we do. This is not our fault, but in the spirit of the Village and what we do for our residents, we don't want to walk away from the problem, but we also have an issue for our own road and hillside.

Mayor Bacci and Mr. Sciano explained that everything in that area has been documented everything that has happened in that area for a long time. This is a very serious issue, and hopefully we can find a solution. This stability study will help us to find out what we need to do.

Motion to approve Geo Sci to perform slope stability analysis and other pertinent studies to investigate the water main break on E. 71st Street.

Mr. Casini gave an overview of the Building Department for 2018. Our physical and industrial base was very active last year, and we expect the same for 2019. We had 29 home loan grant

through the George Suhy Grant legislation for 2018, and 14 for 2017. We issued 28 construction permits, and 140 contractor licenses. We issued 40 licenses already for January of 2019, and we expect a lot of construction. The Building Department revenue is just shy of \$180,000.00 for 2018. We issued 15 permits for Charter Steel this past year for a fast track project. Many of our other local businesses were issued permits for construction in 2018. We are working on finalizing all State and County reports and putting all of our forms online.
