Mr. Schoeffler asked if we had anything in writing as far as how long we will give them to get out of the property. Mayor Bacci explained that once the sale has gone through, Mr. Chojnacki is going to come up with a road map of how we are going to manage the property. We are going to be incredibly sensitive to the family's needs, and unless we have something that needs to be done to the property, we will work with them as long as possible.

OTHER BUSINESS:

Motion to approve Brian Fragua as our next full time Policeman in Cuyahoga Heights.

Mr. Bloam agreed to make the motion, seconded by Mr. Schoeffler.

MAYORS REPORT:

The Mayor explained that he will not need any time in Executive Session until the next Workshop.

The Mayor asked the Building Commissioner to give Council an update of the work they have done with the property on 4657 E. 49th Street, and also with the residential home inspections.

Mr. Casini said that he met with Service Director Sammons to review the needs of the home to bring it up to code. There is a lot of dry rot in the gutter areas, the whole heating system and water heating system has deteriorated and will need to be replaced, the baseboard heating and carpet need to be replaced, the windows will need to be addressed to meet the standard for egret and egress, the electrical needs to be replaced, and it also needs a new roof.

The house has been vacant for quite a long time, and there are quite a few requirements that would need to be addressed to bring it up to code. Functionally, I would never design a home the way it is set up. Anybody that would want to live there would have to rehabilitate the spaces to make it livable. Taking all of this information into consideration, the cost that it would take to rehabilitate this home would equal the cost of a new home. It is his strong consideration to remove the home.

Mr. Schoeffler asked Mr. Casini what constitutes vacancy, and if the homes in the Village that are vacant need to be brought up to code before being sold. A lengthy conversation occurred, and then Mr. Chojnacki read the 1492.25 of the Code which covers vacancies. He explained that the Abuilding Department has the discretion to make the determination if a home is vacant.

Mayor Bacci asked Mr. Sciano to talk about the joint venture with Cuyahoga Heights, Garfield Heights, and Valley View concerning the Canal Road Project.

Mr. Sciano explained that we received a 50/50 grant for our portion of the project. Since both communities are resurfacing parts of Canal Road, it makes sense that we partner with them to get the road to completion from E.71st to Mill Creek.

Mr. Schoeffler asked if we were going to do thermoplastic lines for the road. Mr. Sciano recommended that we do use it since it passes the three year mark for breakeven costs.

Mr. Contipelli asked if there was any way we could make it easier to make a left turn into Bacci Park. Mr. Sciano explained that there just isn't enough room to make any changes.

Mr. Centa asked when we are going to start our widening of the Route 21 crossover. Mayor Bacci said he doesn't have a specific date yet. He explained that after the ramp is reopened, there will still be work to do. He explained that our lane going south on Route 21 will run with the abutment until you reach south of the cloverleaf, and then you will be able to merge into two lanes. Mr. Contipelli asked if we are going to put a light at the intersection. Mayor Bacci said we are going to put up a stop sign. The agreement was a stop sign with limited hours to make a left hand turn. We are just happy it is going to happen.

Mayor Bacci asked Engineer Sciano what he thought the time frame will be for this project. Mr. Sciano said unfortunately we cannot do our work until ODOT finishes theirs. This was stipulated by ODOT because of a liability issue of who would control the traffic flow during the work, and who would be responsible for an accident if there are two different crews working in the same area at the same time.
