**NOVEMBER 13, 2019** 

Before the meeting, Mayor Bacci introduced Mr. Jim Zwizler and School Superintendant Tom Evans to give us an update from the BEST Committee regarding information concerning our schools.

Mr. Evans reported that the Department of Education gave our school system an "A" for all grades for our school district. This is great for our students, parents, teachers, and our community. He explained that 26% of our graduating seniors earned honors diplomas.

The Safety Committee is looking for new door locking devices for the elementary school, and thanked Fire Chief Suhy, and Police Chief Sturgill for helping them.

They are still working on getting money for the Capital Improvements Plan, for total renovations of our buildings. We are also looking at a new heating system, and getting all new LED lighting for the school buildings. After the first of the year, we will have a better idea of what the actual costs will be.

Mr. Evans thanked the Mayor and Council for agreeing to the new sign that will be used by the school and the village. It will be a great addition to the community.

Mayor Bacci thanked them for keeping us updated on all the work they are doing. We are proud to have such a good working relationship to help the school and village be successful.

Council thanked Mr. Zwisler and Superintendant Evans for keeping everyone updated on what is happening at the school.

CFO Angel Meriwether explained that the financials and bank requisitions for the CIC will be up for quarterly review with the CIC, and signed off by the President and Vice-President.
