Mr. Unger and Ms. Meriwether made it very clear that we could not afford to continue getting large increases in the health care plan without making changes. Mayor Bacci explained that we are currently in a three year contract with the bargaining units, and coming out of this contract in 2023, we will most likely see imminent changes in our health care because of the huge yearly rate increases.

Next year, we need to start looking at all of our different options for 2023. It is up to that body to make everyone a part of the solution to our health care increases. Ms. Henley, who attended the meeting said that was the message given to the bargaining unit by Mr. Unger and Ms. Meriwether.

Mr. Schoeffler asked if we could send them to the County. Mayor Bacci said during this Covid period, the County is not accepting any prisoners unless it is a heinous crime. With the amount of money it costs to house prisoners, we cannot justify the cost to keep them here at the Village Jail.

A motion authorizing the Village's Chief Fiscal Officer to create a purchase order for the annual operation and maintenance within the Village of Cuyahoga Heights for the Flexible & Rigid Pavement Repairs for the second half of 2020 Season.

Ms. Henley made the motion to have the CFO create a Purchase Order for Flexible & Ridgid Pavement Repairs for the second half of the 2020 season, seconded by Mr. Contipelli. All in favor, none opposed. Motion carried.

A motion to authorize the Village Engineer to solicit proposals from qualified professionals to perform the Benjamin Moore Demolition and Redevelopment Project, to authorize the Mayor and his designees to evaluate said proposals and negotiate the terms and conditions of performance of the Project.

Mr. Contipelli made the motion to authorize the Engineer to solicit proposals to perform the Benjamin Moore Demolition and to authorize the Mayor to evaluate said proposals and negotiate the terms, seconded by Mr. Centa. All in favor, none opposed. Motion carried.

MAYOR AND COUNCIL REPORTS:

MAYOR BACCI:

Mayor Bacci has reached out to the schools to see if the Town Hall could help in any way during the pandemic with distance learning. All of the Mayors from the three communities have gotten together in the conversation, and if there is a safe way to accommodate some of the students, we would look into it. It is not to accommodate all of the children, it is to help those kids to give them some structure. It is not to house the entire school district. It is to help those that need structure, to help those whose parents work, to help those that need a place on certain days, to give parents a break. It is an outreach to assist those in need. We are proposing that the basement of the Village Hall, as well as the upstairs of the Village Hall, be maintained separately from the main floor of the Village Hall, with students having separate entrances, with doors closed to any and all employees. The school district will have to staff, manage, sanitize, and clean areas that are used during that time. This is still a work in progress, and conversations are still ongoing as to what will happen. Superintendent Evans is working with all of the villages to see if they can be of service to the school. There are many families that are struggling to find solutions on how to manage children distance learning while they have to work, and we want to help them. Before we do this, we will make sure that it will be as safe as possible, and the Mayor will pass on the information as he gets it.

Dan "Tuzzy" Tucholski passed away on July 23 after a long battle with cancer; he was 77. Please keep the family in your thoughts and prayers.

Thank you for the appointment of Jeffrey Heintz who will replace Randy Eliason. Randy retires on August 17th. He is a great guy who never had a problem with anybody. If you had a problem with Eli, you had a problem with yourself. He was a very likeable person. Patrolman Jamie Lucas is retiring on August 17th as well. Jamie had 20 years on the department, and Eli had 34.

We have a Proclamation that will be given to Ohio Crankshaft Company on their one hundredth anniversary. Unfortunately, they had to cancel their celebration due to the pandemic, but we are incredibly happy and honored to have them in the village. Congratulations!

My office has been working with Drug Mart and Nurse Socausky—and we are still planning on having flu shots and blood work for our senior citizens on Friday, September 11 as originally scheduled. However, the location will be Klima Gardens instead of the Village Hall auditorium and strictly by appointment only, and no sit-down breakfast. We are working out the details and hope to have the information to our seniors in the next several weeks.
