#### Cuyahoga Heights Village Charter - ARTICLE II — SECTION 1. ELECTIVE OFFICIALS.

The elective officials of the Village shall be the Mayor, the Clerk and six (6) Council Members elected at large. Said officials shall be elected at the time and in the manner provided by law for the election of Village officials commencing on January 1, following their election as follows:

a. (noted under Mayor's section) b. (noted under Clerk's section)

c. Commencing at the regular municipal election in 2017, Council Members shall be elected in a manner creating staggered terms of four (4) years. The terms of Council Members shall be staggered such that the three (3) individuals who receive the highest vote totals at the regular municipal election in 2017 shall be elected for a four (4) year term and every four years thereafter. The three (3) individuals who achieve the next three (3) highest vote totals (i.e., members receiving the fourth, fifth and sixth highest vote totals) in the regular municipal election in 2017 shall serve a two (2) year term. At the regular municipal election in 2019, the three (3) individuals who receive the three (3) highest vote totals in that election shall be elected to four (4) year terms and every fourth year thereafter. (Amended 11-5-68; 11-4-08; 5-5-09; 11-8-16) (The Charter was adopted by the electors of the Village of Cuyahoga Heights on August 2, 1919, to become effective January 1, 1920.)

As mandated by law, including a system of check and balances, the Cuyahoga Heights Village Charter provides for a six member village council as the legislative branch of local government. Council's duties are to handle the purse strings of the Village's finances and be true watchdogs of the taxpayers' monies. Other duties include committee work and creating, amending, enacting or repealing laws known as the *Codified Ordinances of the Village of Cuyahoga Heights*. Originally, Council's terms of office were two years.

Recently, the Village Charter was amended to make terms of office four years with Council's terms broken down to three members elected to commence a four year term, then the other three members will serve two year terms until 2019 when the top three elected in an opposite time frame will begin their four year term. This staggering allows for stability within the ranks of Council so that there would never be a completely new and less experienced body serving the village.

Over the years, our village councils in tandem with our mayors and clerks, have done their work and today we see the fruits of their efforts. Although there may have been some points in our history where issues were hotly contested and cooperation with the Mayor was intermittent, for the most part there has been a united effort. Stories have been told about an angry former Mayor Gerdon knocking council member Bill Randle out of his council chair—literally! Recent councils have learned that teamwork is of the utmost importance for those seeking to truly represent the community.

#### Village Clerk. Finance and Record Keeping.

#### Cuyahoga Heights Village Charter - Article II — SECTION 1. ELECTIVE OFFICIALS.

b. Commencing at the regular municipal election in 2009, the Clerk shall be elected for a term of four (4) years and every fourth year thereafter commencing on the first day of January next following such election, and shall serve until his or her successor is duly elected and qualified."

The historically elected position of Village Clerk is yet another area where checks and balances in government is key. Although this job is called "clerk," it has meant many things. In the past, for many years, it meant Clerk of Council but also the finance person as well, charged with creating budgets, allocating monies to an assortment of funds and keeping things in good order. Per law, this position was balanced and checked by the elected job of the Village Treasurer. As treasurer, one would write checks to pay the bills and keep ledgers, handwritten, of those expenses as well as incoming funds. These two people were challenged with making certain the books balanced—revenues and expenditures!

The Auditor of State is charged with biennial reviews, audits if you will, of the books of all municipalities within the state. Villages are audited every other year. The purpose of these review and recommendations are to make certain no laws are being broken and that best financial practices are being used within the community. As time passed, the village which has its own Charter, called upon its voters to eliminate the Treasurer's job and worked toward separating the Clerk of Council's job into one area and carving out the Chief Fiscal Officer's position as an appointed, not elected, job. This became a reality in January, 2018.


#### Norbert Chase, who is now 91 years of age, was the longtime clerk of the village.

Norbert married Gloria Pallini in 1949. They had eight children: Jeff, Marilyn, Lorraine, Mark, Sandra, Connie, Michelle and Michael. The family lived at 4941 East 71st Street for many years.
