She doesn't feel we are getting our money's worth out of the current exterminator.

Ms. Henley related these problems to the Mayor. He informed Council that he took up this issue with Service Director Sammons, and he has handled it. He has had a discussion with the exterminator, and if we get any more complaints, we will address them. If someone is getting an unsatisfactory result from the exterminator service the Village provides, we need to know so we can document and address the vendor.

#### POLICE CHIEF STRURGILL:

Flags will be flown at half-mast for the Police Memorial Week. He also told Council that he had the pleasure of meeting some new residents from Willowbrook. #### **ENGINEER TODD SCIANO:**

On lower E.71st Street, the Water Department brought in an outside contractor to find the leak, and as of today, we have no firm results. We have always had a leak at the lower part of the street, but since 2017-2018 the leak was found at a higher level of the street. There is no way to know all the damage until we turn off the water completely. There is also damage even higher than the crossover level, and at this point we are at the mercy of Cleveland Water to help us solve the problem.

Mayor Bacci said we are trying to work with them on their schedule which is overwhelming the amount of work they have to contend with, but we need to get this fixed. No activity doesn't mean we aren't concerned, or making calls to try to resolve this issue. It is a huge concern to all of us, and we will continue to be reasonable with them, and hopefully we will see something soon.
