ENGINEER TODD SCIANO:

The kids loved the corn maze so much better than the one from last year with the bales of hay. Mayor Bacci said we will continue with this next year, and it is much less expensive.

BUILDING COMMISSIONER NORM CASINI:

We are working with the Service Department and the Building Department to fix the leaks at the pool, and to investigate where they are coming from. We are working with a company called Raindrop for splash pads and other various surface features. We are also looking into the possibility of doing a second floor recreation facility which might have a track and exercise facility.

Mayor Bacci said we hope to have something for Public Works and Council for their approval in November to get these studies done. We must fix the leaks at the pool, but all the other ideas we have for the pool that could make it a four seasons building so that folks could utilize it in the winter months possibly with a heated area will be some of the options we will be looking into. At a minimum we need to update the office, locker room, and the aesthetics. How it will work is all the aesthetics to the pool will be done in the spring, while any structural improvements would be done in the fall after the pool closed.
