Each sign application must include:

- 1. Application completed in **FULL**.
- 2. Three (3) sets of drawings to scale. ARCHITECTURAL REVIEW REQUIRES SUBMITTAL OF COLORED RENDERINGS.
- 3. Plot plan/elevation showing the exact location of the sign in relation to the building, right-of-way and property lines.
- 4. Colored photographs/rendering of existing/proposed buildings.
- 5. All temporary signs must have date of sign installation, owner's name and telephone number.

NOTE: Applications and all materials required <u>MUST</u> be submitted to the Building Department no later than <u>NOON</u>, <u>ONE WEEK PRIOR TO THE MEETING DATE</u>, to be placed on the agenda if a variance is required.

The Building Department shall review the drawings for conformance, and if a variance is required, the applicant shall be referred to the Board of Planning and Zoning Appeals, who meet on the third Wednesday of each month at 1:00 p.m. or 6:00 p.m. in the Council Chambers in the Village Hall, 4863 East 71st Street; a representative needs to be present.
