January 11, 2023

COUNCIL PRESIDENT CONTIPELLI CALLS CAUCUS TO ORDER at 5:00 p.m.

MAYOR BACCI CALLED ROLL CALL: Bloam, Centa, Contipelli, Henley, Unger, Volek
