## COUNCIL PRESIDENT CONTIPELLI CALLS CAUCUS TO ORDER at 4:35 p.m.

MAYOR BACCI CALLED ROLL CALL: Bloam, Centa, Contipelli, Henley, Unger, Volek

Mr. Contipelli turned the meeting over to the mayor.

Mayor Bacci asked Mr. Sciano to give council an update on the Benjamin Moore project, its grant process and next demo phase.

Mr. Sciano let council know in December 2022, the village received the award letter for the grant funds of \$442,000, a combination of Cuyahoga County and DOD. At the December council meeting, Council approved plans and specs of the demo of building 4 and the inside of building 5. Those plans were put together last month, we bid it through the month of January and it is in this month's packet. The contractor has an April 30<sup>th</sup>, 2023 deadline to meet the grant requirements. This timeline is short and there will be a lot of activity. Building 5 will stay and from there going north around wrapping the flagpole, will be a small wall that will be allow us to drop the parking lot grade and allow entrance at the lower level and will be ADA compliant.

Mr. Centa asked Mr. Sciano if the building 5 will be staying up or demolished.

Mr. Sciano responded that yes, the whole front of the building will be staying and whatever gets built will tie into it in the future as office space or it'll be a pathway into the parking lot from Grant Ave.

Mr. Contipelli asked Mr. Sciano if this will be complete the demolition of the site.

Mr. Sciano responded that the demolition work will include the inside stripping of the building 5, stone pad, building a retaining wall and removal of asphalt.

Mayor Bacci concluded that after discussing the cost of the various options with Mr. Sciano, it was decided that leaving the building up and using the grant money for the retaining wall will be a positive.

Mr. Contipelli introduced Halli Martin from the Cuyahoga County Treasury's Office. She is the public outreach coordinator for this area.

Ms. Martin introduced herself and thanked the mayor and council for the invitation to the meeting.

Ms. Martin spoke to council about a plethora of the programs that Cuyahoga County offers to residents to assist with paying their property taxes. A listing of those programs and their benefits are available at the village hall.

The mayor updated council on the Marcelline Court properties. Mr. Sciano surveyed the site and got a total of 87 feet for the two properties combined. The mayor is looking at home plans with 2 ½ car garage attached to construct there. They plan to talk to builders soon.

Mr. Sciano explained to council the grant process would be similar to the Bletch Court demolition's as the village is using the County Landbank demo funds, and will have limited control over the demolition process.

The mayor also let council know the service department cleaned up the property at 901 Harvard Ave. They will continue to clean and improve the property and then market it.

A letter will be going out to the residents on the Courts updating them about the demos.

Mayor asked President Contipelli about an upcoming workshop he is requesting.

Mr. Contipelli requested that the council have their workshop on February 22.

Mayor Bacci announced that after the ball season, we will erect the softball diamond dugouts.

The mayor asked to go into executive session for real estate matters.

Mr. Contipelli made the motion to go into executive session. Seconded by Mr. Unger. All in favor, none opposed. Motion approved.

Executive session began at 5:30 pm.

Executive Session ended at 5:48 p.m.

Mr. Chojnacki let the council know that legislation amending the amount payable as a moral claim before them currently has no amount. It was brought to his attention from Chief Sturgill that the amount of the ordinance has been \$300 for some time and would like council to raise it. Mr. Chojnacki request council it had to select a new amount.

Mr. Contipelli asked if there was an amount in mind.

Mr. Chojnacki replied not yet.

Ms. Henley asked if Chief Sturgill had a reason why he wanted it raised.

Mr. Chojnacki replied that the cost of tires that are affected by the stop sticks that are used during police chases.

Mr. Bloam asked if will be a flat fee or case by case occurrence.

Mr. Chojnacki responded it will be a flat fee.

Council and the mayor agreed to \$1,000.00 would be a fair amount.

Mr. Chojnacki announced the legislation Resolution 2023-08 will officially state the amount of \$1,000.00.

Mr. Volek asked the mayor about the streetlights on E.71st going south on the bridge on Rt.21 are all out except for four lamps.

Mayor Bacci responded to Mr. Volek that Chief Sturgill has been in contact with Ms. Robinson from the Illuminating Company and to ask him about it in the council meeting.
