#### **COUNCIL MEETING**

#### January 10, 2024

# MR. CONTIPELLI CALLED CAUCUS TO ORDER at 5:00 p.m.

MAYOR BACCI CALLED ROLL CALL: Bloam, Centa, Contipelli, Schoeffler, Unger, Volek

Mr. Contipelli welcomed Mr. Schoeffler back to council and asked if he had any questions about the legislation.

Mr. Centa inquired about an issue with the property on Harvard Avenue. Engineer Sciano advised that there is a sewer maintenance matter that needs to be looked into further.

Mr. Contipelli also asked council to resume his position as Council President for 2024.

Mayor Bacci asked Mr. Centa to continue to be our school liaison, as well as taking the role of our senior citizens liaison, which had been previously handled by Ms. Henley. Mr. Schoeffler will be placed on the Health and Housing Stock committees, as well as taking Mr. Contipelli's place on the Public Works Committee.

The mayor asked each council member to find a resident who would like to be appointed to the Charter Review Committee; he will pick two residents as well to serve on the committee. He asked that the information be given to him prior to the February council meeting. In addition, the mayor advised council that they will appoint the Pool and Concession Stand Managers at the February council meeting.

The mayor noted that while talking with Mr. Contipelli, if there are any concerns for a council workshop, a meeting will then be held. He also mentioned that he and Ms. Schoeffler are working with CFO Meriwether and Village Engineer Sciano on a letter to residents and businesses concerning project updates. Most importantly, the traffic on East 71st Street will be difficult, especially when school is in session. A separate mailer will be going out to the residents about trail updates, possible exercise stations at the park, and the Grant Avenue road project.

The mayor noted that in the 2024 village calendar there was an error stating that there will be an Arbor Day celebration. This event is held every two years—in the odd years, so the next celebration will be April 2025. He asked council to advise any residents who inquire about the event.

Mayor Bacci turned the meeting over to Law Director Chojnacki for a more in-depth detail about the investigative reporters and our December Mayor's Court. Law Director Chojnacki explained that The Marshall Project is an organization that examines inequities within courts. The founder of The Marshall Project, Mark Puente, along with a reporter from News Channel 5 inquired about how we processed our December 2023 Mayor's Court and made a few public record requests. We have responded and provided all requested documents and have made our Village Magistrate Dean

DePiero available, who will speak to Mr. Puente in the near future. Mayor Bacci also added that our court is for traffic violations, nothing higher than that. Our December court had 25 people and the gift cards were donated to St. Hermans House in downtown Cleveland by the Cuyahoga Heights Police Department.

Mayor Bacci asked CFO Meriwether to give Mr. Centa a quick overview of the Charter Steel Enterprise Zone. CFO Meriwether stated that the Enterprise Zone is a tax incentive that the village gives companies for economic development in which the company brings in a certain amount of jobs to the village, in return—the village gives them a tax incentive on their property taxes. She further noted that we have a committee that reviews this every year, and also we do a community cost share working with our schools to offset their loss on property tax to make sure the school is whole. We currently have one that is up and running and another that will be coming up within the next 24 months.

Councilman Centa wanted to know what a LUCAS device is for the Fire Department. Mayor Bacci stated that a LUCAS device provides mechanical chest compressions to patients in cardiac arrest, it is used as an alternative to manual CPR because it provides consistent compressions at a fixed rate through potentially difficult transport conditions and eliminates the physical strain on the person performing CPR. The village received a grant through Firehouse Subs in a prior application round to purchase a LUCAS device for one ambulance. If awarded, the current application would allow for grant funds to purchase an additional LUCAS device to be placed in another vehicle.

Mayor Bacci noted that there are numerous businesses that are looking to join the community as it relates to the Hillside property; we just want to make sure that it is the best fit for the community.

He also mentioned that Expert Crane has left their facility as they outgrew it. However, they leased their building to Motion Industries for a 5-year lease and our building department is working with them on an occupancy permit.

Also, a Cleveland Water Department contractor is to begin work on January 22 to repair the 30" main leak on East 71<sup>st</sup> Street just north of the 1-77 ramp; the work is going to take approximately two weeks.

Mayor Bacci also advised council that we received a grant from DOPWIC for the Grant Avenue project which will be about \$286,000 savings to the village. However, the project will not start until July 1 and will continue for 365 days; noting that all traffic will be directed to go south on East 71<sup>st</sup> Street.

Mayor Bacci noted that Building Commissioner Casini has been home and recovering from hip surgery which he had on December 27 and is doing well.

Caucus ended at 5:38 p.m.

Before the meeting, Mayor Bacci swore in Councilmen Contipelli, Centa and Schoeffler.
