**COUNCIL PRESIDENT CONTIPELLI CALLED CAUCUS TO ORDER at 5:02 p.m.**

President Contipelli informed council that there were two pieces of legislations that were added to the agenda.

CFO Meriwether advised council that the position for the Parks & Recreation Director was posted online on LinkedIn and Indeed last week and there were over 130 applications submitted. The post has since been taken off the sites, and we are currently interviewing.

The mayor reviewed pictures and pricing from a catalog for exercise equipment for Bacci Park and also updated everyone on the swimming pool. He also advised that Mrs. Kelly Hartman will return as the Concession Stand Manager for this season, and thanked council for supporting her reappointment. Mrs. Hartman and the mayor spoke before the meeting and confirmed that food trucks will be returning once a week for the months of June and July. June trucks will be at Bacci Park and July trucks will be at the pool.
